It covers eleven areas of your work including governance, planning, user involvement, finance, resources, partnership working and so forth. 
#### Speaking and Presentation Skills (One day course)

#### **Finding Donors**

Recent research looking at the type of people who donate to charities came up with five different categories of donors:

 Protectors – people motivated by causes which directly impact them

•Believers – people who donate because they believe in the cause, as they have been shown that there is a compelling need

·Pioneers – donors donate as a way of expressing their life values

•Responders – donors who respond to a specific need or emergency •Joiners – people who donate as part of a social activity or people who want to feel part of a group.

Therefore, if you want to encourage people to donate to your charity, try and ensure that your message is likely to appeal to one or more of these groups.

## Influencing the influencers

A research report just published suggests that adults are more likely to hear about charities from "social influencers" rather than the charities themselves and that people under 30 are more likely to trust the words of these influencers.

#### Finding funding for energy efficiencies is difficult

It has been found that most community buildings do not meet basic energy efficiency standards and there is a danger that energy bills may well deplete community groups' resources very quickly. Many community groups rent or lease buildings from local councils, who sadly do not see community energy bills as a major priority. If you are in this situation, you will need to lobby your local councillors to take some action.

#### Remember to emphasise the benefits of volunteering

Rather than publicising the need for volunteers, spend more time accentuating the benefits to the volunteer. In a recent survey four in five volunteers in ten larger charities said that being involved improved their wellbeing. 69% said that they had gained new skills, whilst 85% felt that their organisation offered them great flexibility in their volunteer commitment.

#### Make sure your information and funds are safe

A recent report found that one third of charities had experienced some sort of cyber attack on their security systems; thankfully, most had been repelled by the security the organisation had in place. This percentage rises to 66% in charities with income over £500k a year. This shows a 25% increase from the previous year. Most of the attacks (83%) were from phishing (fake emails to induce you to reveal personal information or passwords), 37% from impersonation and 14% from malware.
